Loaner Vehicle Agreement Terms

1. Eligibility Requirements

- o Must be at least 25 years old.
- o Must have a valid driver's license.
- o Must provide valid and active proof of insurance.
- o Must sign this agreement before taking possession of the loaner vehicle.

2. Customer Responsibilities

- o If the loaner vehicle is not returned with the same fuel level, a refueling charge will apply per gallon, and an additional inconvenience fee.
- o Report any damages or issues immediately to TLC Auto.
- o Drive responsibly and adhere to all New York State traffic laws.
- o Do not allow anyone else to operate the vehicle.
- o No smoking, eating, or pets are allowed in the vehicle.
- o Return the vehicle within 24 hours of being notified that your repair is complete.
- o Maintain the interior and exterior condition of the vehicle.
- o Customer is liable for all tolls, tickets, traffic violations, and towing expenses during the loan period.

3. Prohibited Uses

- o Use for rideshare, delivery, commercial, or off-road purposes.
- o Driving under the influence of alcohol or drugs.
- o Leaving the state of New York without prior written approval.

4. Damages and Liability

- o Customer assumes full responsibility for any damages caused to the loaner vehicle while in their possession.
- o In the event of an accident, customer agrees to file a police report and notify TLC Auto within 24 hours.
- o Customer's insurance will be the primary coverage for any loss or damage. TLC Auto & Truck Center reserves the right to pursue reimbursement for any uninsured loss.

5. Indemnification

- o Customer agrees to indemnify and hold harmless TLC Auto & Truck Center, its employees, and affiliates from all claims, damages, liabilities, costs, or expenses arising from the use of the loaner vehicle.

6. Failure to Return Vehicle

- o Failure to return the vehicle on time may result in a daily charge of \$100 and legal recovery action.
